 - i) **DM/1162/23/OUT**- Outline erection of 42 dwellings and associated infrastructure with all matters reserved- **Withdrawn**
 - ii) **DM/1120/23/FUL**- Erect new timber framed entrance porch to front and create two new balconies on top of existing single storey flat roof extensions to the rear- **Approved**
 - iii) **DM/1163/23/CEA**- Proposed use of the existing dwelling as a residential children's care home, for a maximum of 3 resident children receiving care aged 10-17, with 2 non-resident care staff support falling within Use Class C2. **Refused**
- b) To consider the following application received from NELC:-
 - i) **DM/1239/23/REM**- Variation of condition 1 (Approved plans) as granted on DM/1103/17/REM - amendment to boundary treatment to replace close boarded fence with hedging, amendment to second floor to provide a study and the introduction of a velux window, addition of photovoltaics and minor internal alterations.

RESOLVED: Barnoldby le Beck recommended continued refusal of this application due to no changes affecting planning decisions

c) Consider the proposed draft local plan [Draft Plan with Options | NELC \(nelincs.gov.uk\)](#)

- Concerns raised regarding inflated job creation. The plan won't reflect redundancies and jobs that will transfer within the energy industry
- Concerns raised as to how the plan is considered to be over ambitious housing targets, and the 5 year assessment will mean that villages like Barnoldby le Beck will be impacted
- Neighbouring village, Waltham has a huge amount of housing planned and the roads services won't be able to cope with the traffic/ no infrastructure in place
- Traffic that will develop from the proposed sites at neighbouring villages will be immense especially at peak time, residents are already struggling at the moment with Barnoldby le Beck village being used as a diversion
- Birdseye site 2019 – still not populated
- Green wedges – Councillors raised the importance to keep the strategic gap between villages vs amalgamating villages to merge into one village
- More information regarding infrastructure and traffic required
- Concern regarding Scartho top development

 - ii) Resident raised concerns about their objections to the National Grid Proposal to Build Pylons to run 140km of high voltage cables through the Lincolnshire Countryside. Resident asked if this could be added to the agenda, representatives from the consultations advertised were approached to see if they could attend the Parish meeting however, unable to secure attendance. Resident has also liaised directly with Ward Councillors regarding concerns of this proposal.
